# NOTICE OF AN APPLICATION FOR THE REGISTRATION OF LAND AS A TOWN OR VILLAGE GREEN

To every reputed owner, lessee, tenant or occupier of any part of the land described below and to all others whom it may concern.

An application has been made to Southend-on-Sea Borough Council ("the Registration Authority"), by Mr Peter Lovett on behalf of the 'Friends of Shoebury Common' under section 15(1) of the Commons Act 2006 and in accordance with the Commons (Registration of Town or Village Greens) (Interim Arrangements) (England) Regulations 2007. The application seeks the inclusion in the register of town and village greens of the land described in the Schedule below which is claimed to have qualified for registration as a town or village green by virtue of Section 15(2) of the Commons Act 2006 that a significant number of the inhabitants of any locality, or of any neighbourhood within a locality, have indulged as of right in lawful sports and pastimes on the land for a period of at least 20 years and they continue to do so at the time of the application.
