Reason for the project:

Government invited submissions for the Emergency Active Travel Fund Tranche 2 programme. This is designed to develop cycling and walking infrastructure in light of Covid-19. The Council has taken the opportunity to submit key policies and ambitions identified in the Local Transport Plan 3. These projects work towards ambitions across south Essex. They also work towards Southend-on-Sea Borough Council's revised ambitions and objectives, called Southend 2050. These have been revised to include Covid-19 recovery. The Council's submission to the Active Travel Fund was mostly successful.

The project will take forward three of the five proposed schemes. These are called:

Scheme 1: Holistic Network Wide Cycle Audit and Master Planning of A13 Active Travel Corridor

Scheme 2: Prittlebrook Greenway - Lighting and Connectivity Improvements

Scheme 3: School Streets

Scheme 4: Cycling Improvements to the Public Realm and Economic Hubs

- Scheme 1: Holistic Network Wide Cycle Audit and Master Planning of A13 Active Travel Corridor
 - Audit
 - Implementation Plan (subject to further future consultation Summer 2021)
- Scheme 2: Prittlebrook Greenway Lighting and Connectivity Improvements
 - Solar powered LED street lighting
- Scheme 3: School streets





- Site specific interventions based on learning from Tranche 1 initial schemes
- Scheme 4: Cycling Improvements to the Public Realm and Economic Hubs
 - Adding secure cycle parking facilities including electric cycle charging points
 - Monitoring and evaluation of schemes

What constraints are there?

Due to the emergency nature of the fund, some of the above has already begun. Where they have started, we will take the opportunity to measure and evaluate the impact of them.

Delivery timescales are very short, so the consultation, engagement and review of the schemes will often be carried out at the same time as delivering them. Opportunities to review and adjust interventions in light of feedback and evaluation will be built into the delivery timeline.

Has a budget been identified to pay for related engagement and consultation work? If so, how much? Yes, £15,000

Any local issues/sensitivities/politics to be taken into consideration?

Tranche 1 of the Emergency Active Travel Fund gave very little time to undertake consultation with local communities.

There had not been the opportunity to consult on any of the schemes implemented or proposed. This means some schemes could not be brought forward. Some schemes that were started as emergency measures, received a negative reaction from local communities.

The emergency nature of Tranche 1 meant proposals had not been able to be included in the forward plan. This has been rectified for Tranche 2.

Consultation and Engagement Mandate

Southend-on-Sea Borough Council needs to understand the views of local residents, businesses, organisations and road-users. We seek their views on our proposals for the development of walking and cycling facilities and infrastructure across Southend-on-Sea. This will help us develop and successfully deliver the outline schemes agreed and funded by the Department for Transport Active Travel Fund. They will then be delivered by 31st March 2021. This will improve the walking and cycling facilities in Southend-on-Sea.
