

Southend-on-Sea City Council Trade Union Facility Time Report for 2024-25

The Trade Union (Facility Time Publication Requirements) Regulations 2017 put in place the provisions in the Trade Union Act 2016 requiring relevant public sector employers to publish specified information related to facility time provided to trade union officials which must be published on a Government website and on the organisation's own website. These reports are published annually by 31st July for the period 1st April of the previous year to 31st March of the current year.

In the case of a Local Authority, it must comply with the reporting requirement separately in relation to

- its central function employees;
- its education function employees; and
- its fire and rescue function employees

The Council does not have fire and rescue function employees so this report provides two sets of figures – those for facility time relating to 'Central Function employees' (City Council Employees) and facility time relating to 'Education Function Employees' (Community School Employees).

The information that has to be published is set out at Schedule 2 of the Regulations, in the form of tables. This report uses the format of those tables to set out the required information in the two sets of figures set out below.
