

**THE SOUTHEND-ON-SEA BOROUGH COUNCIL (VARIOUS ROADS) (STOPPING, WAITING, LOADING AND UNLOADING PROHIBITIONS AND RESTRICTIONS, PARKING PLACES AND PERMIT PARKING ZONES) (CONSOLIDATION) ORDER 2016 (AMENDMENT NO. 13) ORDER 2018**

**Road Traffic Regulation Act 1984**

**NOTICE IS HEREBY GIVEN** that Southend-on-Sea Borough Council proposes to make the above Order under Sections 1, 2, 4, and 124 (and part IV of Schedule 9) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance to Part III of Schedule 9 to the act of 1984 as amended by Part 6 of the Traffic Management Act 2004 the effect of which will amend the above-mentioned Consolidation Order by the adding of the items listed below and the updating of Map Tile Schedules, K15, K16, L15

**To introduce No Waiting at Any Time on the following lengths of Road**

Road	Side of Road	Proposed Description
Eastwoodbury Lane	North	10 metres either side of its junction with Bristol Road
Eastwoodbury Lane	North	10 metres either side of its junction with Vickers Road
Eastwoodbury Lane	South	10 metres west of its junction with Eastwoodbury Crescent
Bristol Road	Both	10 metres north of its junction with Eastwoodbury Lane
Bristol Road	Both	10 metres south of its junction with Wells Avenue
Vickers Road	Both	10 metres north of its junction with Eastwoodbury Lane
Vickers Road	Both	10 metres south of its junction with Wells Avenue
Wells Avenue	South	10 metres either side of its junction with Bristol Road
Wells Avenue	South	10 metres either side of its junction with Vickers Road
Eastwoodbury Crescent	West	from its junction with Eastwoodbury Lane southwards for approx. 14m
Eastwoodbury Crescent	Both	10 metres from its junction with Rochford Road Service Road (North West)
Rochford Road Service Road (North West)	Both	10 metres south west of its junction with Eastwoodbury Crescent
Rochford Road Service Road (North West)	Both	10 metres north east of its junction with Eastwoodbury Crescent
Rochford Road	North West	10 metres both sides of its junction with Eastwoodbury Crescent
Rochford Road	South East	13 metres north east of its junction with Rochford Road Service Road (South East) to a point 10 metres south west of its junction with Rochford Road Service Road (South East)
Rochford Road Service Road (South East)	Both	From its junction with Rochford Road north eastwards for a distance of approx. 13 metres
Alton Gardens	South East	10 metres either side of its junction with Derek Gardens
Derek Gardens	Both	10 metres south east of its junction with Alton Gardens

Alton Gardens	North West	From approx. 15 metres from its junction with Manners Way to outside No.89 Alton Gardens

Rochford Road	South East	Outside Nos.138 and 148 Rochford Road
