	For each additional 142 yards or 36 seconds (or a combination of parts of such distance or time) when a fare of £13.10 is shown on the taxi meter	30p

Extra Charges

For any luggage carried. No charge for disabled persons wheelchairs, disability aids or any animal transported in the vehicle 40p
(Maximum charge)

For each person in excess of one 40p

Specific requests for the delivery of property left in taxis must be paid for at the metered fare

Soiling Charge

A reasonable charge may be levied for restoration costs should you soil or damage this vehicle. The proprietor reserves the right to take civil action where necessary.
