

**SOUTHEND-ON-SEA BOROUGH COUNCIL
(RIVERA DRIVE, ILFRACOMBE AVENUE & LOVELACE AVENUE SOUTHEND-ON-SEA)
(TEMPORARY PROHIBITION OF TRAFFIC, PARKING, STOPPING, WAITING, LOADING &
UNLOADING) ORDER 2020**

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)

Notice is hereby given that the Southend-on-Sea Borough Council intends, not less than seven days from the date of this notice, to make the above Order under Section 14(1) of the Road Traffic Regulation Act 1984.

The Effect of the order will be to prohibit any vehicle from

Phase 1

1. Proceeding on Rivera Drive from its junction with Lovelace Avenue to outside & opposite No27 Rivera Drive
2. Exiting & entering Ilfracombe Avenue at its junction with Rivera Drive
3. Parking, stopping, waiting, loading & unloading on Rivera Drive from its junction with Lovelace Avenue to outside & opposite No27 Rivera Drive
4. Parking, stopping, waiting, loading & unloading on Ilfracombe Avenue from its junction with Rivera Drive to outside & opposite No21 Ilfracombe Avenue

Phase 2

5. Proceeding on Rivera Drive from its junction with Surbiton Avenue to outside & opposite No37 Rivera Drive
6. Exiting & entering Lovelace Avenue at its junction with Rivera Drive
7. Parking, stopping, waiting, loading & unloading on Rivera Drive from its junction with Surbiton Avenue to outside & opposite No37 Rivera Drive
8. Parking, stopping, waiting, loading & unloading on Lovelace Avenue from its junction with Rivera Drive to outside & opposite No38 Lovelace Avenue.

The Order will come into effect on 6th July 2020 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.

The alternative route will be via;-

For both phases Rivera Drive, Chase Road, Southchurch Road & Dalmatia Road.

The closure is required for the safety of the public and workforce whilst gas main replacement works take place.

Access for emergency vehicles, residents and pedestrians will be maintained at all times during the closure.

The prohibitions or restrictions will apply only during such time and to such extent as indicated by traffic signs prescribed by the **TRAFFIC SIGNS REGULATIONS AND GENERAL DIRECTIONS 2016**

Any vehicle waiting in contravention of any restriction/prohibition imposed by this Notice may be issued with a Penalty Charge Notice and removed under the provisions of the Traffic Management Act 2004
