

Statement of Reasons

Proposals

On street:

Southend-on-Sea City Council intend to amend charges across all existing on-street payment parking places at various locations across the City of Southend-on-Sea, with free parking applied on Christmas day only. These proposals are following approval by Southend-on-Sea City Council Cabinet and Full Council during February 2023. This applies to all on- street pay and display charges, as well as all applicable permit type charges.

It is proposed that the chargeable period for Zone 1A will be extended, with charges applying between 8am and 9pm Monday to Sunday.

It is proposed that motorcycles be subject to the on-street parking charges in chargeable payment parking places.

An introduction of a fee for Members' parking permits and New Church Road Permits, which are currently free of charge, and the introduction of an on- and off-street Tradesperson Permit option.

Off street:

Southend-on-Sea City Council intend to amend charges across all existing off-street payment parking places at various locations with free parking being applied on Christmas day. There is also free parking applicable under the remit of one small business day per annum in car parks located within Zones 2 & 3 only. These proposals are following approval by Southend-on-Sea City Council Cabinet and Full Council during February 2023. This includes both pay and display charges as well as all applicable permit types and season ticket charges.

To introduce parking charges in Zone 3 off-street pay and display (car parks), with the exception that the first hour will be designated as free parking but chargeable after that.

To introduce new parking charges in the car parks within Parks & Open Spaces, where the first hour will be designated as free parking but chargeable after that.

It is proposed that the chargeable period for Zone 1A will be extended. Charges will apply between 8am and 9pm Monday to Sunday in Zone 1A, except for Shorefield Road Car Park and Cliffs Pavilion Car Park which will remain as Monday – Sunday 8am – 6pm.

Introduction of a number of cashless parking spaces in Baxter Avenue Car Park, whilst all other bays remain allocated for season ticket holders only.

The addition of coach parking places in Shoebury East Beach Car Park.

A change to the closing time for University Square Car Park; the shutters will close at 9pm.

It is also proposed that motorcycles be subject to the off-street parking charges in chargeable payment parking places.

An introduction of a fee for Members' parking permits, which are currently free of charge, and, introduction of an on and off-street Tradesperson Permit option.

Statement of Reasons

Reasons

The primary reason for charging for parking is to effectively manage kerb-side space and demand, in both central on-street locations and car parks as well as residential and business areas.

Effective parking management will aim to support wider transport policy objectives, ensuring that on and off-street space is used more effectively.

Additional reasons include;

- To cover the ongoing expenses incurred in maintaining and operating parking restrictions and its facilities within the City.
- To ensure that the Council continues to manage the demand for parking within the City to ensure that residents, businesses, and visitors receive the best parking service from the Council.
- Account for inflation in line with Consumer Price Index (CPI).

Effective management of parking provision is recognised as making a significant contribution to reducing congestion, whilst supporting access to residents, visitors and businesses.

Parking tariffs need to be set at a level which facilitates local use and demand and at a level which will ensure the effective management of parking provision by prioritising access to the local community and promoting a sustainable and vibrant local economy.

The provision for additional coach parking bays in off-street areas will aim to encourage visitation to the area and allow coaches to access and wait in the City of Southend-on-Sea at a safe location off the highway.

It is envisaged that the changes in tariffs will encourage people to look at alternatives to parking, such as considering more sustainable and active travel modes.

The introduction of parking charges for motorcycles will ensure a consistent approach to charges across various classes of vehicles City-wide and may assist to discourage single use trips.

The addition of a number of cashless parking spaces in Baxter Avenue Car Park, and the extension of the chargeable hours to Zone 1A, will aim to help manage high demand in this central area of the City, including the nighttime economy.

Any income generated from on-street parking charges will be utilised to effectively manage parking in the first instance. Any surplus generated by the operation of the on-street parking service is used for other improvements in traffic management, highway improvements, environmental improvements, and subsidised and concessionary transport. This is in accordance with the current legislation and associated regulations.

Legislation

Charges for on-street parking can be varied by Notice under the Road Traffic Regulation Act 1984, Section 46a and compliance with Part V, Section 25 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996. Due to additional changes being required for both on and off-street provisions, as set out in the proposal section of this document, an amendment Order for on-street, and separate amendment Order for off-street, will cover all changes proposed, including the increased charges element.

The specific grounds with which the Council are using for the implementation of the proposals are encompassed in Sections 1, 2, 4, 32, 35, 44, 45, 46, 46A, and 124(1)(d) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

In considering whether to make this Order, Southend-on-Sea City Council has had regard to all

relevant matters including its responsibility pursuant to Section 122 of the Road Traffic Regulation Act 1984 (as amended), to secure so far as practicable the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians), and the provision of suitable and adequate parking facilities on and off the highway having regard to the matters specified in Section 122(2).

Equality Act 2010, Section 149

Consideration has been given to the equalities duty of Southend-on-Sea City Council.

The Southend on Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.

Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 32, 33, 35 and 44 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act hereby give notice that it proposes the following.

- Increase off-street parking charges;
- Introduce parking charges for motorcycles;
- Introduce a Tradesperson Permit for use both on- and off-street, which will be in addition to the existing Tradespersons Permit for on-street only;
- Introduce a number of cashless parking spaces at Baxter Avenue Car Park;
- Introduce coach parking places at Shoebury East Beach Car Park;
- Change the closing time for University Square Car Park (shutter closing time changing to 9pm);
- Extend the chargeable period for Zone 1A, to include Monday to Sunday 8am-9pm (except Shorefield Road Car Park and Cliffs Pavilion Car Park which will remain as Monday – Sunday 8am – 6pm);
- To introduce car parking charges in Zone 3 off-street pay and display (car parks), with the exception that the first hour will be designated as free parking but chargeable after that; and
- To change car parking charges in car parks within Parks & Open Spaces. The first hour will be designated as free parking but chargeable after that.

The changes to the fees and charges for off-street parking will amend the following Order:

Southend-on-Sea City Council in exercise of its powers under sections 32, 33, 35, 35C and 44 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order THE SOUTHEND-ON-SEA CITY COUNCIL TRAFFIC MANAGEMENT ORDER THE SOUTHEND-ON-SEA CITY COUNCIL (OFF-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2022 No. 6 (as amended) (To be known as 'The 2022 Order') and shall have effect;
 - (i) The new varied charges items described in Schedule 1 to this Order shall replace the corresponding charges in Schedule 2 of The 2022 Order.
 - (ii) The insertion of new entries and new charges described in Schedule 2 to this Order into Schedule 3 of The 2022 Order.
 - (iii) The new charges items for the permits described in Schedule 3 to this Order shall replace the corresponding charges for those permits set out in Schedule 3 of The 2022 Order.
 - (iv) The table set out in Schedule 4 to this order will be replace the items in Schedule 1 of The 2022 Order.
2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):
 - (i) Introduce new off-street parking charges
 - (ii) The inclusion of solo motorcycles to be subject to off-street parking charges under the same provisions as set out in articles 4 and 5 of the 2021 Order.
 - (iii) Extend the chargeable period for Zone 1A, to include Monday – Sunday 8am – 9pm, except Shorefield Road Car Park and Cliffs Pavilion Car Park which will remain as Monday – Sunday 8am – 6pm.
 - (iv) Introduce a new Tradespersons Permit for use both on and off-street.
 - (v) Introduce a number of cashless parking bays in Baxter Avenue Car Park
 - (vi) Introduce coach parking places at Shoebury East Beach Car Park
 - (vii) Amend the closing time of University Square Car Park, to 9pm.

- (viii) Introduce a parking charge in Zone 3 off-street pay and display (car parks), with the exception that the first hour that will have a £0.00 charge.
- (ix) Introduce new parking charges in car parks within Parks & Open Spaces, where the first hour will have a £0.00 charge.
