  - (i) The items represented on the plans in Schedule 1 to this Order shall replace those plans as listed in the appropriate Schedule to The 2021 Order (as amended)
  - (ii) The streets listed in Column 2 of the table in Schedule 2 to this Order will have affect as the restrictions listed in Column 1 of the table in Schedule 2 to this Order will be proposed
- The effect of this Order is to (this article is an explanatory note this is not part of the Order)
  - (i) Reduce the current operational and chargeable period for Zone 1A payment parking bays, to include Monday Sunday 8am 6pm
- The remainder of The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect
- This Order shall come into effect on the 27th day of July 2023 and may be cited as "The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Operational Times Amendment) (Zone 1A) Amendment No 24 Order 2023
