Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984 , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Beach Avenue) Amendment No.12 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Manor Road) Amendment No.13 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.14 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Terminal Close / Shoebury Avenue Junction) Amendment No.15 Order 2025

The effect of the Traffic Regulation Orders (TRO) will be to:

PTO1139 – Beach Avenue

To amend the current No Waiting, 8am – 6pm, (single yellow line) restrictions to No Waiting, Monday – Friday, 10am – 4pm, within Beach Avenue on the west side of the road, from the property boundary of No.113 and No.115 to its junction with Leigh Road.

PTO1140 – Manor Road

To introduce 8.8 metres of No Waiting at Any Time (double yellow line) restrictions, at the northern entrance to the flats on Manor Road.

PTO1059 – Blatches Chase / Whitehouse Road Junction

At the junction of Blatches Chase and Whitehouse Road, introduce No Waiting at Any Time (double yellow lines) restrictions. The measurements are as follows; on the west side of the road, 28 metres west and 10 metres north; on the east side of the road, 10 metres east and 10 metres north.

PTO1110 – Terminal Close / Shoebury Avenue Junction

To extend the current restrictions at the junction of Terminal Close and Shoebury Avenue to 10 metres on both sides, and to extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.

These changes will amend the following Order: The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (to be known as ‘The 2021 Order’). The remainder of ‘The 2021 Order’ will remain in full force and effect. Map-based Schedules to replace plans in the appropriate schedule of ‘The 2021 Order’ (as amended). The amendment shall come into operation on 21st August 2025 and may be cited as:

The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Beach Avenue) Amendment No.12 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Manor Road) Amendment No.13 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.14 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Terminal Close / Shoebury Avenue Junction) Amendment No.15 Order 2025

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Orders were made, make an application for the purpose to the High Court.

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:


1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as 'The 2021 Order') shall have effect as though;
 - At the junction of Blatches Chase and Whitehouse Road, introduce No Waiting at Any Time (double yellow lines).
2. The effect of this Order is to (this article is an explanatory note this is not part of the Order) introduce No Waiting at Any Time and No Loading and Unloading at Any Time restrictions at the junction of Blatches Chase and Whitehouse Road, which crosses St Laurence Ward and Eastwood Park Ward.

The junction protection measurements proposed are as follows:

 - a) On the West side of the road - 28 metres West and 10 metres North.
 - b) On the East side of the road – 10 metres East and 10 metres North.
3. The remainder of "The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended)" shall remain in full force and effect.
4. This Order shall come into effect on the 21st day of August 2025 and may be cited as "THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (BLATCHES CHASE AND WHITEHOUSE ROAD JUNCTION) AMENDMENT NO.14 ORDER 2025"

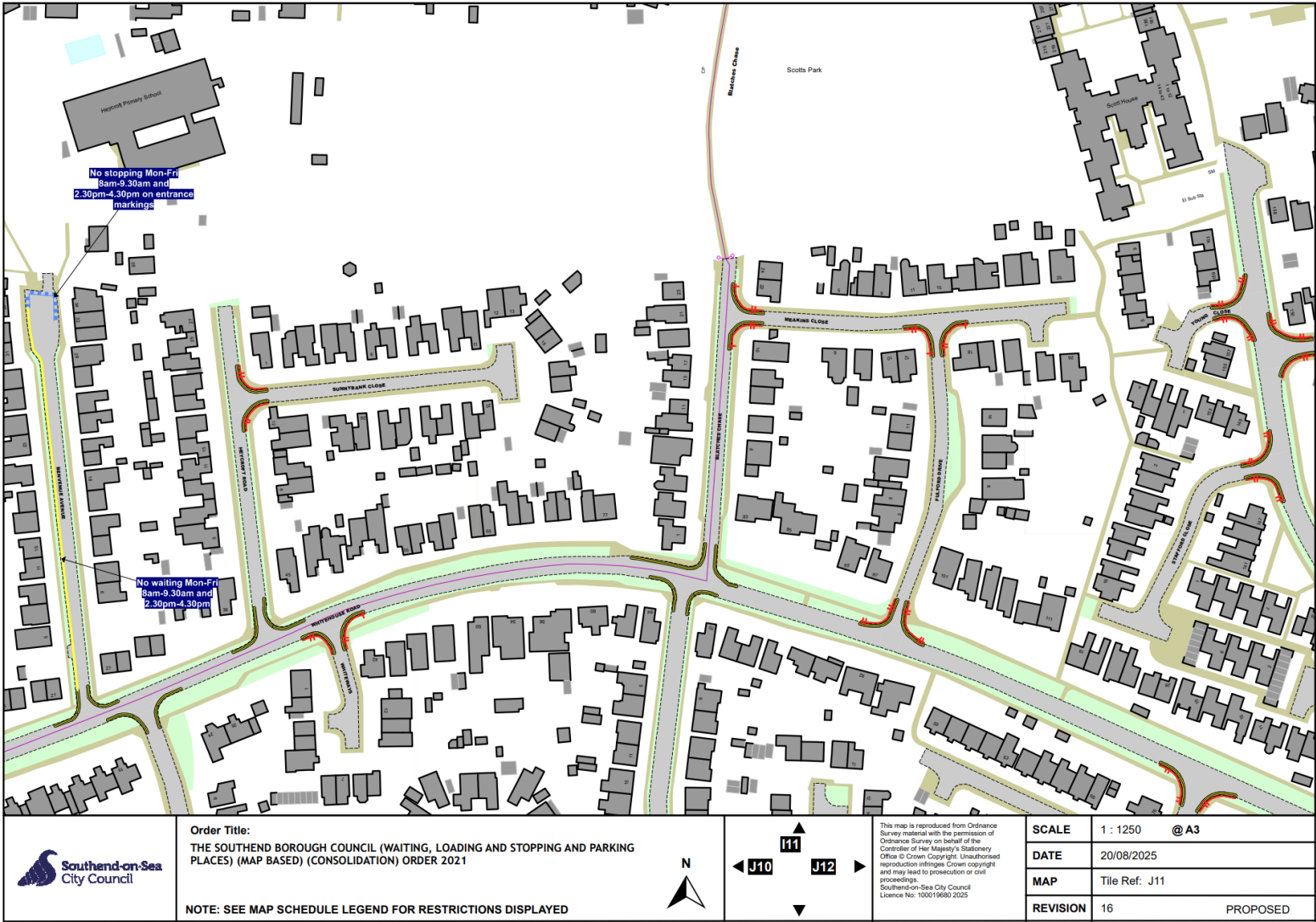

Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby give notice that it intends to make the following Amendment Order:

The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.* Order 2024

The effect of the Traffic Regulation Order (TRO) would be to:

At the junction of Blatches Chase and Whitehouse Road, introduce junction protection restrictions, No Waiting at Any Time (double yellow lines) and No Loading and Unloading at Any Time (double yellow kerb blips).

The junction protection measurements proposed are as follows:

On the West side of the road - 28 metres West and 10 metres North.

On the East side of the road – 10 metres East and 10 metres North.

Statement of Reason

The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.14 Order 2025

Proposal

The proposal is to introduce No Waiting at Any Time and No Loading and Unloading at Any Time restrictions at the junction of Blatches Chase and Whitehouse Road, which crosses St Laurence Ward and Eastwood Park Ward.

Reason

Junction protection measures are proposed to reinforce the Highway Code (rule 243) that vehicles should not park within 10m (32 feet) of a junction, for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, and for facilitating the passage on the road or any other road of any class of traffic including pedestrians being seen and wishing to cross the road at the junction.

Road Traffic Regulation Act 1984

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

Traffic Signs Regulations and General Directions 2016

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

Equality Act 2010

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010

Due Regard for Traffic Orders and Notices

The Southend-on-Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.
