

THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021

THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (INCREASED CHARGES) (VARIOUS AMENDMENTS) AMENDMENT NO.5 ORDER 2025

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4, 45 and 46 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order The SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021 No. 1 (To be known as 'The 2021 Order') and shall have effect;

- (i) The items represented on the plans in Schedule 1 to this Order shall replace those plans as listed in the appropriate Schedule to The 2021 Order (as amended).
- (ii) The removal of permits and charges described in Schedule 2 to this Order from Article 5 of The 2021 Order (as amended).
- (iii) The insertion of new entries and new charges described in Schedule 3 to this Order into Article 5 of The 2021 Order (as amended).
- (iv) The introduction of the following definitions into Article 2 (b) to the 2021 Order (as amended):

"Resident Permit - Company Vehicle" means a Permit which can only be issued in accordance with the Council's terms and conditions to an eligible resident Permit Holder or a resident concessionary Permit Holder, for use with a Company Vehicle.

"Company Vehicle" means a vehicle registered to a company/business of which is used by the resident Permit Holder or a resident concessionary Permit Holder.

"Commuter Tariff (Daily)" means a reduced Parking charge available to a Southend Pass customer may utilise when parking in locations specified on the Council's website.

"Pay and Display" means a Parking Place to which a payment for parking applies on leaving a Vehicle in that Parking Place designated as such by this Order and where Payment of the parking charge, as set out in Article 5 of this order, is made by means of a Pay and Display Machine or ticketless payment options (via approved devices such as telephone, application, website, debit or credit card).

- (v) Amend the definition for 'Electric Vehicle' in Article 2 (b) to the 2021 Order (as amended) as follows:

"electric vehicle" means a vehicle (not including a hybrid electric vehicle) in which the electrical motive power is derived from an electrical battery that is not connected to any source of power when the vehicle is in motion;

- (vi) Introduce the following Article after Article 19 of the 2021 Order (as amended) as follows:

Commuter Tariff (Daily)

Residents with an existing Southend Pass may utilise a Commuter Tariff (Daily) to use at locations specified on the Council's website.

2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):

- (i) Introduce amendments to parking fees and charges.
- (ii) Re-designate tariff zones to ensure consistency, and associated charges.
- (iii) Cap evening charges (Zone 1A and Zone 1B) to be capped at £5 per night (between 6-9pm).
- (iv) Introduce a Winter tariff for Zone 1A to be introduced during the months of November, December, January.
- (v) Cap all-day parking charges capped at £17(Zone 1B)/£20(Zone 1A) on the central seafront.
- (vi) Cap all-day parking charges at £10 outside of the central seafront between 8am and 6pm.
- (vii) Freeze Southend Pass subscription costs, with the removal of the existing three-month payment option, as shown in Schedule 3 to this Order.
- (viii) Introduce the following Permits charges have been introduced as shown in Schedule 3 to this Order:
 - a. A Resident Permit - Company Vehicle
 - b. Visitor Vouchers (Virtual/Electronic Book of 20)
 - c. Commuter Tariff (Daily)
- (ix) Apply inflationary increases applied on permits and season tickets

3. The remainder of the Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.

4. This Order shall come into effect on the 1st day April 2025 and may be cited as "THE SOUTHEND BOROUGH COUNCIL (WAITING, LOADING AND STOPPING AND PARKING PLACES) (MAP BASED) (CONSOLIDATION) ORDER 2021. THE SOUTHEND-ON-SEA

CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED)
(INCREASED CHARGES) (VARIOUS AMENDMENTS) AMENDMENT NO.5 ORDER 2025".
