Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Beach Avenue) Amendment No.12 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Manor Road) Amendment No.13 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.14 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Terminal Close / Shoebury Avenue Junction) Amendment No.15 Order 2025

The effect of the Traffic Regulation Orders (TRO) will be to:

#### PTO1139 – Beach Avenue

To amend the current No Waiting, 8am – 6pm, (single yellow line) restrictions to No Waiting, Monday – Friday, 10am – 4pm, within Beach Avenue on the west side of the road, from the property boundary of No.113 and No.115 to its junction with Leigh Road.

#### PTO1140 – Manor Road

To introduce 8.8 metres of No Waiting at Any Time (double yellow line) restrictions, at the northern entrance to the flats on Manor Road.

#### PTO1059 – Blatches Chase / Whitehouse Road Junction

At the junction of Blatches Chase and Whitehouse Road, introduce No Waiting at Any Time (double yellow lines) restrictions. The measurements are as follows; on the west side of the road, 28 metres west and 10 metres north; on the east side of the road, 10 metres east and 10 metres north.

#### PTO1110 – Terminal Close / Shoebury Avenue Junction

To extend the current restrictions at the junction of Terminal Close and Shoebury Avenue to 10 metres on both sides, and to extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.

These changes will amend the following Order: The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (to be known as 'The 2021 Order'). The remainder of 'The 2021 Order' will remain in full force and effect. Map-based Schedules to replace plans in the appropriate schedule of 'The 2021 Order' (as amended). The amendment shall come into operation on 21<sup>st</sup> August 2025 and may be cited as:

The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Blatches Chase and Whitehouse Road Junction) Amendment No.14 Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Terminal Close / Shoebury Avenue Junction) Amendment No.15 Order 2025

  - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to The 2021 Order (as amended).
- 2. The effect of this Order is to (this article is an explanatory note this is not part of the Order):
  - To extend the current restrictions at the junction of Terminal Close and Shoebury Avenue to 10 metres on both sides.
  - To extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.
- 3. The remainder of The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.
- This Order shall come into effect on the 21<sup>st</sup> day of August 2025 and may be cited as: "The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021. The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Terminal Close/Shoebury Avenue Junction) Amendment No.15 Order 2025".





• To introduce 5 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Windermere Road, between the two existing School Keep Clear restrictions.

#### PTO1110 – Terminal Close / Shoebury Avenue Junction

- To extend the current restrictions at the junction of Terminal Close and Shoebury Avenue to 10 metres on both sides.
- To extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.

#### PTO1111 – Comet Way outside No.7

• To introduce approximately 45 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Comet Way outside No.7.

#### PTO1125 – London Road parking bay amendments

- To reduce the length of the No Waiting at Any Time (double yellow lines) to 10 metres on the east side of Canvey Road, Sydney Road, Leigh Gardens and Barnard Road at their junctions with the North side of London Road.
- To reduce the length of the No Waiting at Any Time (double yellow lines) to 10 metres on the east side of Sydney Road, Canvey Road, Leigh Gardens and Barnard Road at their junctions with the south side of London Road.

- To introduce Limited Waiting bays (8am-6pm, 2hrs no return within 4hrs) on London Road at the following locations:

  - x1 bay outside No.1621

#### Statement of Reason

#### THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (TERMINAL CLOSE/SHOEBURY AVENUE JUNCTION) AMENDMENT NO.15 ORDER 2025

#### Proposal

The proposal is to:

- To extend the current restrictions at the junction of Terminal Close and Shoebury Avenue to 10 metres on both sides.
- To extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.

#### Reasons

Following a resident complaint regarding HGV movements in Terminal Close, an engineer review was undertaken. Terminal Close, an industrial area and dead-end street, is accessed solely via Shoebury Avenue, a residential street. The complaint highlighted concerns about HGVs driving onto pavements and occasionally into private driveways to manoeuvre. The engineer review identified that these issues were caused by the tight area and parked vehicles, which limit the space available at the junction for HGVs to manoeuvre safely.

#### **Road Traffic Regulation Act 1984**

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

#### **Traffic Signs Regulations and General Directions 2016**

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

#### Equality Act 2010

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.
