Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984 , and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

The effect of the Traffic Regulation Orders (TRO) will be to:

PTO1074 – Watson Close

To extend the existing double yellow lines (No Waiting at Any Time) restrictions at the junction of Watson Close with Ness Road:

- on the west side of Watson Close to the property boundary of No.2 and No.3,
- on the east side of Watson Close to the property boundary of No.18 and No.19.

PTO1111 – Comet Way

- To introduce approximately 45 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Comet Way outside No.7.

PTO1126 – Windermere Road

- To introduce 5 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Windermere Road, between the two existing School Keep Clear restrictions.

PTO1125 – London Road

- To reduce the length of the No Waiting at Any Time (double yellow lines) to 10 metres on the east side of Canvey Road, Sydney Road, Leigh Gardens and Barnard Road at their junctions with the North side of London Road.
- To reduce the length of the No Waiting at Any Time (double yellow lines) to 10 metres on the east side of Sydney Road, Canvey Road, Leigh Gardens and Barnard Road at their junctions with the south side of London Road.
- To introduce Limited Waiting bays (8am-6pm, 2hrs no return within 4hrs) on London Road at the following locations:
 - x2 bays outside No.1378 – No.1380
 - x1 bay outside No.1621

- x1 bay outside No.1354
- x1 bay outside No.1344
- x1 bay outside No.1583

These changes will amend the following Order: The Southend Borough Council (Waiting, Loading and Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (to be known as 'The 2021 Order'). The remainder of 'The 2021 Order' will remain in full force and effect. Map-based Schedules to replace plans in the appropriate schedule of 'The 2021 Order' (as amended). 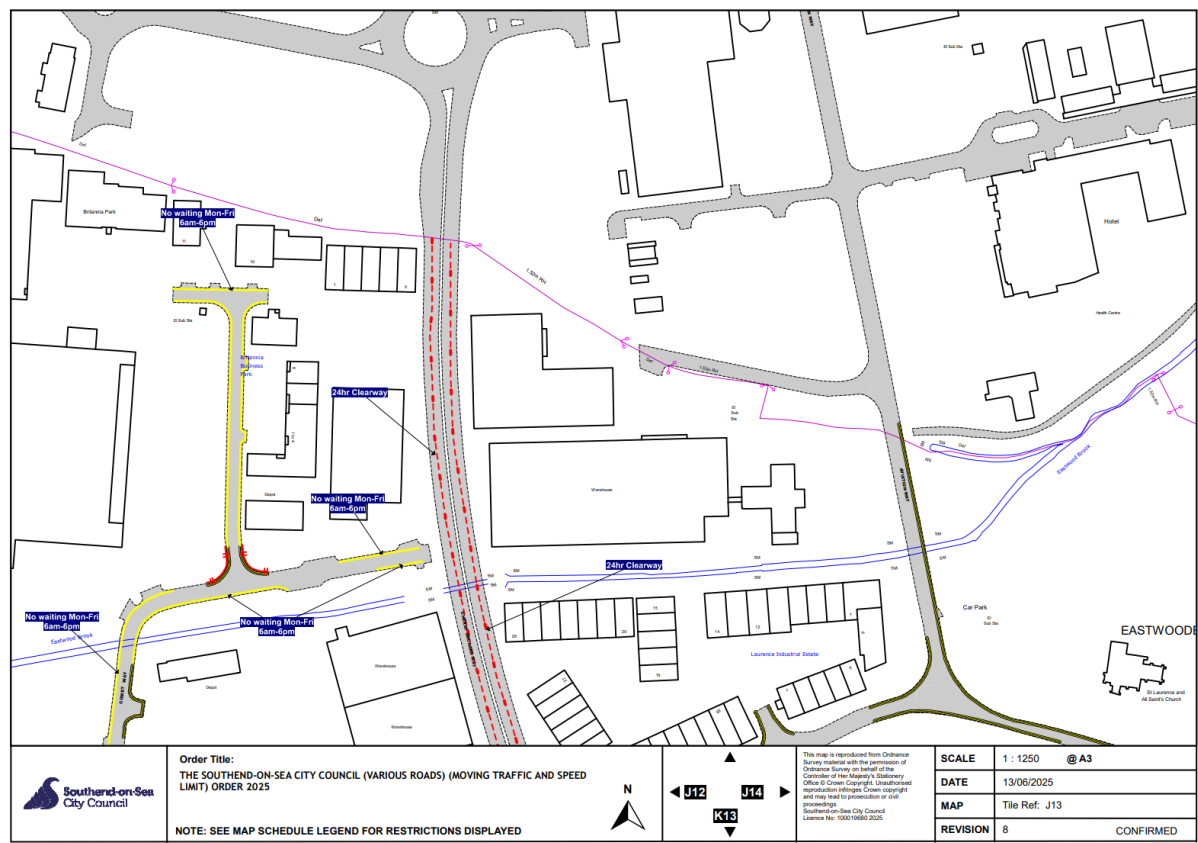

- To extend the current restrictions opposite the junction of Terminal Close and Shoebury Avenue on the east side by 5 metres.

PTO1111 – Comet Way outside No.7

- To introduce approximately 45 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Comet Way outside No.7.

PTO1125 – London Road parking bay amendments

Statement of Reason

THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (COMET WAY OUTSIDE NO.7) AMENDMENT NO.* ORDER 2025

Proposal

The proposal is to:

To introduce approximately 45 metres of No Waiting at Any Time (double yellow lines) restrictions on the east side of Comet Way outside No.7.

Reasons

Following a request from a local business regarding obstructive parking blocking their recently installed vehicle crossover entrance, which restricted access for HGV movements, an engineering review was undertaken. The business raised concerns about vehicles parking in a way that impeding their operations and created difficulties for larger vehicles navigating the area and preventing deliveries. The review confirmed that unrestricted parking near the entrance significantly reduced the available space for HGVs manoeuvring and lead to operational inefficiencies.

The original restrictions agreed were No Waiting, Monday-Friday, 6am-6pm (single yellow lines). However, since the business has been in operation with the newly installed vehicle crossover, it has been raised that the obstructive parking is also occurring on weekends, thereby necessitating the proposal for No Waiting at Any Time (double yellow lines) to address the ongoing problem.

Road Traffic Regulation Act 1984

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

Traffic Signs Regulations and General Directions 2016

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

Equality Act 2010

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.

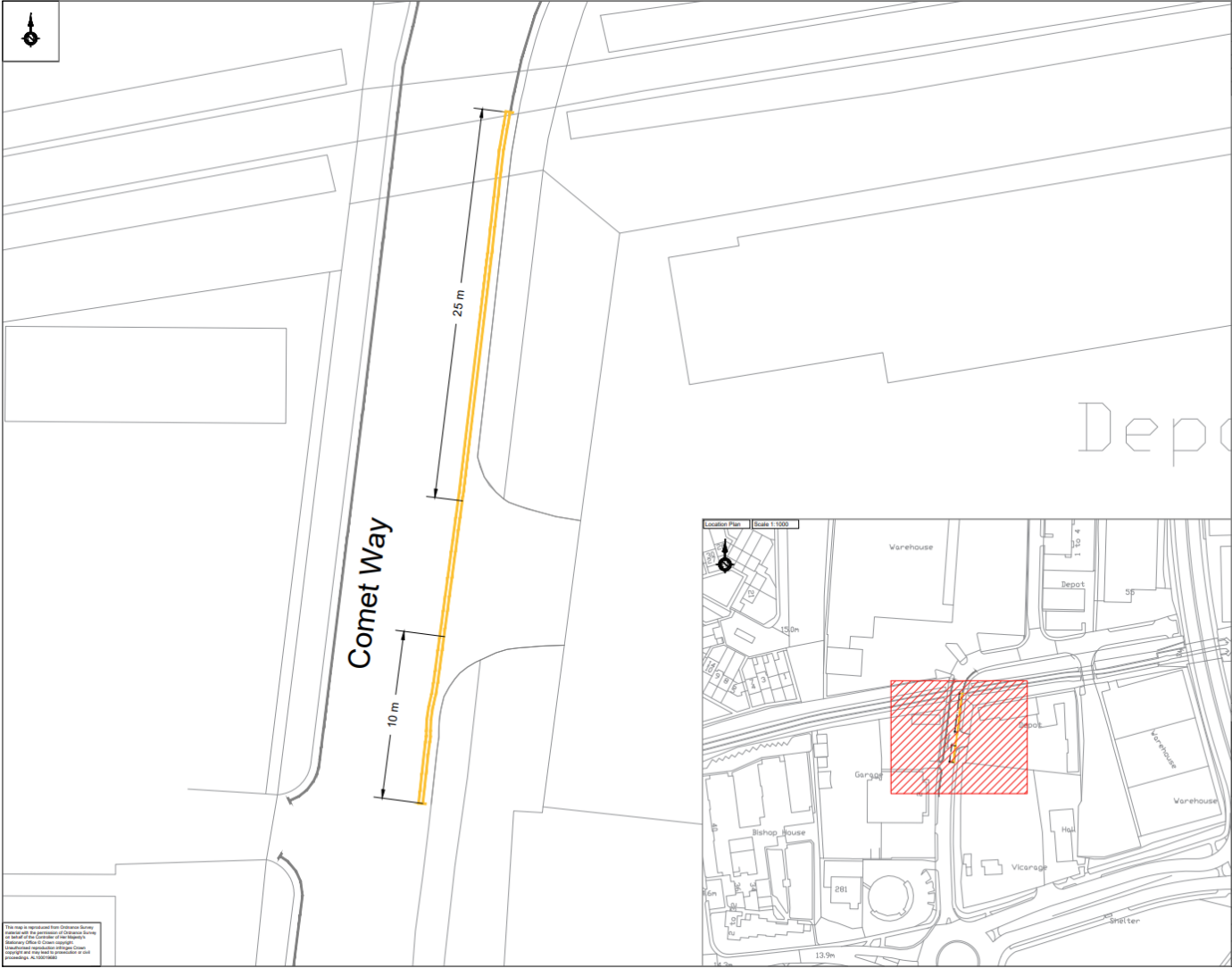
