Authorisation of Design Submission for service disconnection on the Cadent Gas Transportation Network.

I refer to your full design submission, reference EAL2023/1151, received on 27th February 2023. In respect of the above project, I confirm the authorisation of your design proposal on the following terms and conditions, providing your proposed connection is disconnected fully in accordance with the submission here authorised. The terms and conditions applying to this authorisation are, UIP/GT Connection, Service Disconnection and Service Alteration Agreement entered into between you and Cadent and Cadent Gas's current General Conditions of Contract for a Self Lay Pipe (System) Not Exceeding 2,196,000 kWh Systems. The Customer Works detailed below will vest within Cadent Gas Limited upon completion of the final disconnection. To this end I would request that you formally state your intended dates for commencement and completion of the Customer Works and the Works.

This notice is not to be taken as an authorisation to disconnect the Customer Works. The final disconnection clearance to proceed must be obtained through the Cadent Network Controller or the Connections Start Date Notification procedure as applicable.

1. The Authorisation Conditions

The appropriate terms and conditions, detailed above, apply to this Authorisation subject to any express variations or amendments in this Authorisation.

2. The Customer

The Customer is Energy Assets Ltd of 6, ALMONDVALE BUSINES PARK, ALMONDVALE WAY, LIVINGSTON, EH54 6GA.

3. The Customer Works

The Customer Works and the Works shall be the works as described in your submission EAL2023/1151, received 27th February 2023 and as follows disconnect, purge and abandon one non domestic LP service:- approximately 23m of 63mm PE, to be cut back and capped at the 6inch CI LP Cadent main (authorised based on information provided by Energy Assets Ltd. Please submit a DR8 upon completion) and including the Enhancements and Protective Works (where intended to be carried out by the Customer) hereinafter described.

4. Enhancements

Additions to and enhancements or variations of the works originally proposed by the customer and included in the Customer Works and the Works at Cadent's request and with the customer's agreement and in respect of which Cadent has agreed to make an indemnity payment to the customer are: None required

5. Indemnity Amount

The indemnity payment referred to in 4 above is: £0

6. The Reinforcement Works

I can confirm that no reinforcement is required

7. Variations

No employee or agent of Cadent is authorised to alter or amend the Terms and Conditions of this Authorisation other than by the formal issue of a Variation or the issue of a revised Authorisation.

8. Plans

Unless expressly provided to the contrary in the Special Conditions or a Connection contract or a Variation any obligation upon the customer to provide a scaled plan in accordance with IGE/TD/3, IGE/TD/4, IGE/TD/101 and any additional Cadent recording requirements which may be issued from time to time.

For easements, plans should be minimum size A4 or where necessary a maximum size A3 or a cross-referenced section thereof.

During the course of the project, Cadent may carry out such random inspections of the non-commissioned works as it judges necessary. A Cadent Observer may attend site on the day of connection.

Cadent will usually report any concerns regarding the non -commissioned works in line with following categories:

A. Situations posing an immediate risk to life or property *

Action - Notification will be given to personnel on site and an immediate telephone call followed by fax notification will be made to your Company.

B. Construction activities likely to affect the integrity of the pipe and as such in breach of the Authorisation. *

Action - A telephone call followed by fax notification will be made to your Company.

C. Minor discrepancies and/or matters of poor practice. *

Action - Fax notification will be made to your Company.

* In all cases where there is a danger to site personnel, public, security of supply or network integrity on the day of connection, the Cadent site observer will have authority to stop the operation and will also have responsibility for invoking Cadent emergency procedures in the event of an incident.

I would point out that A to C above are not a responsibility of Cadent, however, if Cadent personnel witness such activities we will use our reasonable endeavours to act as described above. Your company must not, however, in the discharge of its contractual responsibilities under the authorisation or otherwise rely upon Cadent's actions or notification in the discharge of its contractual, statutory or other responsibilities relating to or arising from the construction of the Customer Works and the Works.
