**THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (ST LAURENCE JUNCTION PROTECTION PHASE 3) AMENDMENT NO.7 ORDER 2026**

Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (St Laurence Junction Protection Phase 3) Amendment No.7 Order 2026.

The effect of the Traffic Regulation Orders (TROs) would be as follows:

**PTO1098 – St Laurence Junction Protection Phase 3**

To introduce junction protection restrictions - No Waiting at Any Time (double yellow lines) and No Loading or Unloading at Any Time (double yellow kerb blip markings) at the following locations at the approximate distances:

- a) Shepard Close with Neil Armstrong Way – 10 metres on both sides of the junction.
- b) Audleys Close with Alton Gardens – 5 metres in Audleys Close and 10 metres in Alton Gardens.
- c) Vickers Road with Wells Avenue – 10 metres in Vickers Road and 5 metres in Wells Avenue.
- d) Orchard side with Orchard Grove – 5 metres in Orchard Side and 8 metres in Orchard Grove.
- e) Eastwoodbury Close with Eastwoodbury Crescent – 5 metres in Eastwoodbury Close and 5 metres in Eastwoodbury Crescent.
- f) Bristol Road with Wells Avenue – 8 metres on both sides of the junction.
- g) Keith Way with Hampton Gardens – 8 metres on both sides of the junction.
- h) Eastwoodbury Crescent with Rochford Road – 5 metres on both sides of the junction.
- i) Snakes Lane north – 10 metres on both sides of the junction.
- j) Snakes Lane west – 5 metres on both sides of the junction.
- k) Snakes Lane east – 5 metres on both sides of the junction.
- l) Fairlawn Gardens and Fairlawn Gardens – 5 metres on both sides of the junction.
- m) Willmott with Avro Road – 5 metres on both sides of the junction.
- n) Neil Armstrong Way with Neil Armstrong Way side of No.99 – 8 metres on both sides of the junction.
- o) Neil Armstrong Way with Neil Armstrong Way side of No.33 – 10 metres on both sides of the junction.

The amendments shall come into operation on 30<sup>th</sup> March 2026 and may be cited as ‘The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Consolidation) Order 2021’:

- ‘The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (St Laurence Junction Protection Phase 3) Amendment No.7 Order 2026’.

The changes for On-street parking will amend the following Order; ‘The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021’. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Orders were made, make an application for the purpose to the High Court.

**PTO1145 – Fairfield Road**

To introduce No Waiting at Any Time restrictions (double yellow lines) on the east side of Fairfield Road, extending from the property boundary between No.72 and No.74 to a point opposite No.91.

**PTO1134 – Fairfield Gardens / Fairfield Crescent bend**

To introduce No Waiting at Any Time restrictions (double yellow lines) on both sides of Fairfield Gardens, from the property boundary of No.7 and No.9 to the property boundary of No.15 and No.17.

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as 'The 2021 Order') shall have effect as though;
  - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to The 2021 Order (as amended).
  
2. The effect of this Order is to introduce junction protection restrictions - No Waiting at Any Time (double yellow lines) and No Loading or Unloading at Any Time (double yellow kerb blip markings) for 10 metres at each of the junctions (both sides of every road) listed below:
  - (a) Shepard Close with Neil Armstrong Way – 10 metres on both sides of the junction.
  - (b) Audleys Close with Alton Gardens – 5 metres in Audleys Close and 10 metres in Alton Gardens.
  - (c) Vickers Road with Wells Avenue – 10 metres in Vickers Road and 5 metres in Wells Avenue.
  - (d) Orchard side with Orchard Grove – 5 metres in Orchard Side and 8 metres in Orchard Grove.
  - (e) Eastwoodbury Close with Eastwoodbury Crescent – 5 metres in Eastwoodbury Close and 5 metres in Eastwoodbury Crescent.
  - (f) Bristol Road with Wells Avenue – 8 metres on both sides of the junction.
  - (g) Keith Way with Hampton Gardens – 8 metres on both sides of the junction.
  - (h) Eastwoodbury Crescent with Rochford Road – 5 metres on both sides of the junction.
  - (i) Snakes Lane north – 10 metres on both sides of the junction.
  - (j) Snakes Lane west – 5 metres on both sides of the junction.
  - (k) Snakes Lane east – 5 metres on both sides of the junction.
  - (l) Fairlawn Gardens and Fairlawn Gardens – 5 metres on both sides of the junction.
  - (m) Willmott with Avro Road – 5 metres on both sides of the junction.
  - (n) Neil Armstrong Way with Neil Armstrong Way side of No.99 – 8 metres on both sides of the junction.
  - (o) Neil Armstrong Way with Neil Armstrong Way side of No.33 – 10 metres on both sides of the junction.




**Statement of Reason**  
**THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND**  
**PARKING PLACES) (MAP BASED) (ST LAURENCE JUNCTION PROTECTION PHASE**  
**3) AMENDMENT NO.7 ORDER 2026**

**Proposal**

To introduce junction protection restrictions - No Waiting at Any Time (double yellow lines) and No Loading or Unloading at Any Time (double yellow kerb blip markings) at the following locations at the approximate distances:

- (a) Shepard Close with Neil Armstrong Way – 10 metres on both sides of the junction.
- (b) Audleys Close with Alton Gardens – 5 metres in Audleys Close and 10 metres in Alton Gardens.
- (c) Vickers Road with Wells Avenue – 10 metres in Vickers Road and 5 metres in Wells Avenue.
- (d) Orchard side with Orchard Grove – 5 metres in Orchard Side and 8 metres in Orchard Grove.
- (e) Eastwoodbury Close with Eastwoodbury Crescent – 5 metres in Eastwoodbury Close and 5 metres in Eastwoodbury Crescent.
- (f) Bristol Road with Wells Avenue – 8 metres on both sides of the junction.
- (g) Keith Way with Hampton Gardens – 8 metres on both sides of the junction.
- (h) Eastwoodbury Crescent with Rochford Road – 5 metres on both sides of the junction.
- (i) Snakes Lane north – 10 metres on both sides of the junction.
- (j) Snakes Lane west – 5 metres on both sides of the junction.
- (k) Snakes Lane east – 5 metres on both sides of the junction.
- (l) Fairlawn Gardens and Fairlawn Gardens – 5 metres on both sides of the junction.
- (m) Willmott with Avro Road – 5 metres on both sides of the junction.
- (n) Neil Armstrong Way with Neil Armstrong Way side of No.99 – 8 metres on both sides of the junction.
- (o) Neil Armstrong Way with Neil Armstrong Way side of No.33 – 10 metres on both sides of the junction.

**Reason**

Junction protection measures are proposed to reinforce the Highway Code (rule 243) that vehicles should not park within 10m (32 feet) of a junction, for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, and for facilitating the passage on the road or any other road of any class of traffic including pedestrians being seen and wishing to cross the road at the junction.

The length of the restrictions implemented have been considered both in line with the highway code, and the current parking pressure on residents.

**Road Traffic Regulation Act 1984**

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

**Traffic Signs Regulations and General Directions 2016**

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

**Equality Act 2010**

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.

## Due Regard for Traffic Orders and Notices

The Southend-on-Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.
