(TTO25-26-15) ORDER 2025 (LEIGH HILL/ RIVEIRA DRIVE/ CENTRAL AVENUE/ STOCK ROAD/SOUTHBOURNE GROVE/ QUEENSWAY/ PRIORY CRESCENT)

Notice is hereby given that Southend-on-Sea City Council has made the above Order under Section 14(1) of the Road Traffic Regulation Act 1984.

The effect of the Order will be to temporarily prohibit any vehicle from stopping, waiting, loading, unloading and parking at the locations stated in Table 1 of this Notice.

The closures are scheduled to commence on the dates as set out in Table 1 of this Notice or where appropriate signs are showing and weather permitting.

The alternative route for each location will be as set out in Table 1 of this Notice.

The Order will come into effect on 11th August 2025 and may continue in force for a maximum of 18 months or until the works have been completed, whichever is the earlier.

The closure is required for the safety of the public and workforce whilst carriageway and footway patching work takes place.

Access for emergency vehicles, residents and pedestrians will be maintained at all times during the closure.

The prohibitions or restrictions will apply only during such time and to such extent as indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.

Any vehicle waiting in contravention of any restriction/prohibition imposed by this Notice may be issued with a Penalty Charge Notice and removed under the provisions of the Traffic Management Act 2004.
