Notice is hereby given that Southend-on-Sea City Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1, 2, 4, and 122 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act has made the following Orders:

The effect of the Traffic Regulation Orders (TROs) would be as follows:

**PTO1176 – Hamlet Court Road – Loading Bays**

On the west side of Hamlet Court Road, it is proposed to remove the bus stop outside No.171 – 177, replacing this with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between the hours of 8am – 6pm.

On the east side of Hamlet Court Road, it is proposed to remove the bus stop outside No.162 – 168 and replace it with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between 8am – 6pm.

**PTO1166 – St Johns Road outside No.6A**

To revoke 5.5 metres (m) of the existing Resident Permit Holders Only bay (Zone MW, 8am – 6pm) on the north side of St Johns Road, outside No.6/No.6A.

**PTO1143 – Oxford Terrace**

To introduce No Waiting at Any Time (double yellow line) restrictions, within the entire length of Oxford Terrace, on both sides on the road.

The amendments shall come into operation on 28<sup>th</sup> January 2026 and may be cited as 'The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Consolidation) Order 2021':

- 'The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Hamlet Court Road – Loading Bays) Amendment No.4 Order 2026'.
- 'The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (St Johns Road Outside No.6A) Amendment No.5 Order 2026'.
- 'The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Oxford Terrace) Amendment No.6 Order 2026'.

The changes for On-street parking will amend the following Order; 'The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021'. Copies of the Orders, which will come into operation on 28<sup>th</sup> January 2026, the statement of reasons for making the Orders and plans showing the affected streets can be inspected during normal office hours, inclusive for a period of six weeks from the date on which the Orders were made at the Civic Centre, Victoria Avenue, Southend-on-Sea, SS2 6ER and at <https://www.southend.gov.uk/tro>.

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks from the date on which the Orders were made, make an application for the purpose to the High Court.

Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby give notice that it intends to make the following Amendment Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Hamlet Court Road – Loading Bays) Amendment No.\* Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (No.27 Beaufort Street – Disabled Bay) Amendment No.\* Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Progress Road) Amendment No.\* Order 2025

The effect of the Traffic Regulation Orders (TROs) would be as follows:

**PTO1176 – Hamlet Court Road – Loading Bays**

On the west side of Hamlet Court Road, it is proposed to remove the bus stop outside No.171 – 177, replacing this with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between the hours of 8am – 6pm.

On the east side of Hamlet Court Road, it is proposed to remove the bus stop outside No.162 –168 and replace it with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between 8am – 6pm.

**PTO1274 – No.27 Beaufort Street – Disabled Parking Bay**

To introduce a disabled parking bay outside No.27 Beaufort Street.

**PTO1297 – Progress Road**

- The 10 metre (m) taxi rank outside No.60 Progress Road is proposed to be revoked and replace with 10m of No Waiting at Any Time (double yellow lines).
- The 12m taxi rank outside No.60 Progress Road is proposed to be revoked and replace with 12m of No Waiting at Any Time.
- To introduce 6m of No Waiting at Any Time outside No.60 Progress Road.
- The proposal is to revoke 10m of No Waiting at Any Time adjacent to No.1 Brunel Road, replacing this with an 10m taxi rank.
- The proposal is to revoke 12m of No Waiting at Any Time opposite No.55 Progress Road, replacing this with an 12m taxi rank.

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as ‘The 2021 Order’) shall have effect as though:
  - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to the 2021 Order (as amended).
2. The effect of this Order is to (this article is an explanatory note and does not form part of the Order):
  - a) On the west side of Hamlet Court Road, it is proposed to remove the bus stop outside No.171 – 177, replacing this with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between the hours of 8am – 6pm.
  - b) On the east side of Hamlet Court Road, it is proposed to remove the bus stop outside No.162 –168 and replace it with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between 8am – 6pm.
3. The remainder of The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.
4. This Order shall come into effect on the 28<sup>th</sup> day of January 2026 and may be cited as “The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021.



## Schedule 1



### **Statement of Reason**

## **THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND PARKING PLACES) (MAP BASED) (HAMLET COURT ROAD – LOADING BAYS) AMENDMENT NO.4 ORDER 2026**

### **Proposal**

On the west side of Hamlet Court Road, it is proposed to remove the bus stop outside No.171 – 177, replacing this with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between the hours of 8am – 6pm.

On the east side of Hamlet Court Road, it is proposed to remove the bus stop outside No.162 –168 and replace it with a Loading Only bay, limited to 30 minutes, with no return within 2 hours, operating between 8am – 6pm.

### **Reason**

The Bus Stops on Hamlet Court Road have been redundant for a number of years. To effectively manage kerb side space, it is proposed to replace the bus stops with Loading Only bays to support local businesses.

### **Road Traffic Regulation Act 1984**

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

### **Traffic Signs Regulations and General Directions 2016**

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

### **Equality Act 2010**

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.

## Due Regard for Traffic Orders and Notices

The Southend-on-Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.

- Eliminate discrimination, harassment and victimisation and any other conduct prohibited by the ACT;
- Advance equality of opportunity between people who share a protected characteristic and people who do not share it; and
