Southend-on-Sea City Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) (“the 1984 Act”) and the Traffic Management Act 2004 (“the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby give notice that it intends to make the following Amendment Orders:

- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Woodfield Gardens) Amendment No.* Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Highlands Boulevard) Amendment No.* Order 2025
- The Southend-on-Sea City Council (Waiting, Loading, Stopping and Parking Places) (Map-Based) (Hamstel Road) Amendment No.* Order 2025

The effect of the Traffic Regulation Orders (TROs) would be as follows:

PTO1212 – Woodfield Gardens

- a) To introduce No Waiting at Any Time (double yellow line) restrictions on the north side of the road, from the existing restrictions at its junction with Hillside Crescent to the turning circle outside No.59.
- b) To introduce 10 metres (m) of No Waiting at Any Time on the south side of the road outside No.18 to No.20.
- c) To introduce No Waiting at Any Time restrictions on the south side of the road outside No.2 to outside No.48 Hillside Crescent – in line with the existing 10m junction protection restrictions.

PTO1195 – Highlands Boulevard

- a) At the junction of Buxton Avenue and Highlands Boulevard, extend the No Waiting at Any Time (double yellow line) restrictions to 10 metres.
- b) At the junction of Ewan Way and Highlands Boulevard, extend the No Waiting at Any Time restrictions to 10 metres.

PTO1165 – Hamstel Road

- a) To revoke 9 metres of the Limited Waiting bay outside No.241 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).
- b) To revoke 6.5 metres of the Limited Waiting bay outside No.231 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).

Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

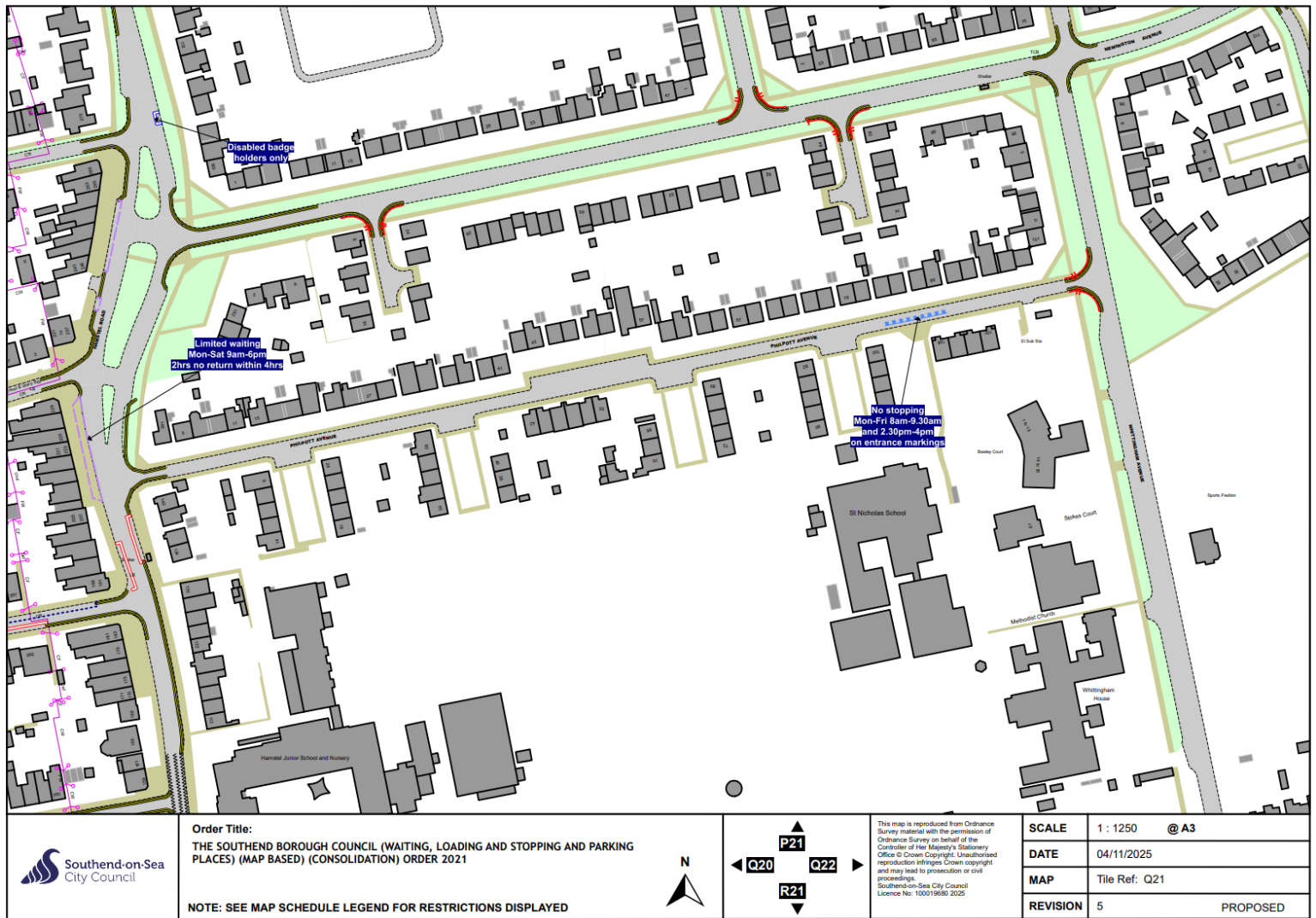
1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as 'The 2021 Order') shall have effect as though:
 - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to the 2021 Order (as amended).
2. The effect of this Order is to (this article is an explanatory note and does not form part of the Order):
 - (a) To revoke 9 metres of the Limited Waiting bay outside No.241 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).
 - (b) To revoke 6.5 metres of the Limited Waiting bay outside No.231 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).
3. The remainder of The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.
4. This Order shall come into effect on the **XX day of Month 202X** and may be cited as "The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021.

Statement of Reason
THE SOUTHEND-ON-SEA CITY COUNCIL (WAITING, LOADING, STOPPING AND

Proposal

- c) To revoke 9 metres of the Limited Waiting bay outside No.241 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).
- d) To revoke 6.5 metres of the Limited Waiting bay outside No.231 Hamstel Road, replacing this with No Waiting at Any Time (double yellow lines).

Reason

The proposal supports the Council's statutory duty under the Road Traffic Regulation Act 1984 to ensure safe and efficient access for the business located at this site. It seeks to maintain unobstructed entry and exit from the premises, allowing vehicles to leave 241 Hamstel Road safely without conflict with oncoming traffic.

The proposed measures will help maintain smooth traffic flow along Hamstel Road and reduce potential safety risks associated with vehicles reversing or emerging into moving traffic.

This approach supports both highway safety and operational access needs for the local business and surrounding area.

Road Traffic Regulation Act 1984

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

Traffic Signs Regulations and General Directions 2016

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.

Equality Act 2010

Thorough consideration was given to the equalities duty of Southend-on-Sea City Council under Section 149 of the Equality Act 2010.

Due Regard for Traffic Orders and Notices

The Southend-on-Sea City Council has a duty to give 'due regard to' the following three aims of the public sector equality duty (section 149 of the Equality Act 2010) during the development of the policy.
