
THE SOUTHEND-ON-SEA CITY COUNCIL (VARIOUS ROADS) (MOVING TRAFFIC AND SPEED LIMIT) AMENDMENT NO. 2 ORDER 2026

The Southend-on-Sea City Council, in exercise of its powers under Sections 65(1), 81, 84, 85, 87, 122 and 124 (and parts I, II and IV of Schedule 9) of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Traffic Management Act 2004 as amended and of all other enabling powers, and having regard to Section 122 of the Act after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order THE SOUTHEND-ON-SEA CITY COUNCIL (VARIOUS ROADS) (MOVING TRAFFIC AND SPEED LIMIT) ORDER 2025 (To be known as 'The 2025 Order') and shall have effect;
 - (1) The items represented on the Map Tile in Schedule 1 to this Order shall replace the corresponding Map Tile as set out in the Map Schedule to The 2025 Order (as amended).
 - (2) Schedule 2 of The 2025 Order is amended by replacing the following Map Tile:
W28 Revision 0 replaced by W28 Revision 1
2. The effect of this Order is to (this article is an explanatory note and is not part of the Order):
 - (1) Introduce a 20mph Speed Limit Zone on Meacham Way, Shoeburyness for its entire length and on Railtrack Way, Shoeburyness for its entire length.
3. The remainder of THE SOUTHEND-ON-SEA CITY COUNCIL (VARIOUS ROADS) (MOVING TRAFFIC AND SPEED LIMIT) ORDER 2025 (as amended) shall remain in full force and effect.
4. This Order shall come into effect on 9th May 2026 and may be cited as "THE SOUTHEND-ON-SEA CITY COUNCIL (VARIOUS ROADS) (MOVING TRAFFIC AND SPEED LIMIT) ORDER 2025 THE SOUTHEND-ON-SEA CITY COUNCIL (VARIOUS ROADS) (MOVING TRAFFIC AND SPEED LIMIT) AMENDMENT NO. 2 ORDER 2026".

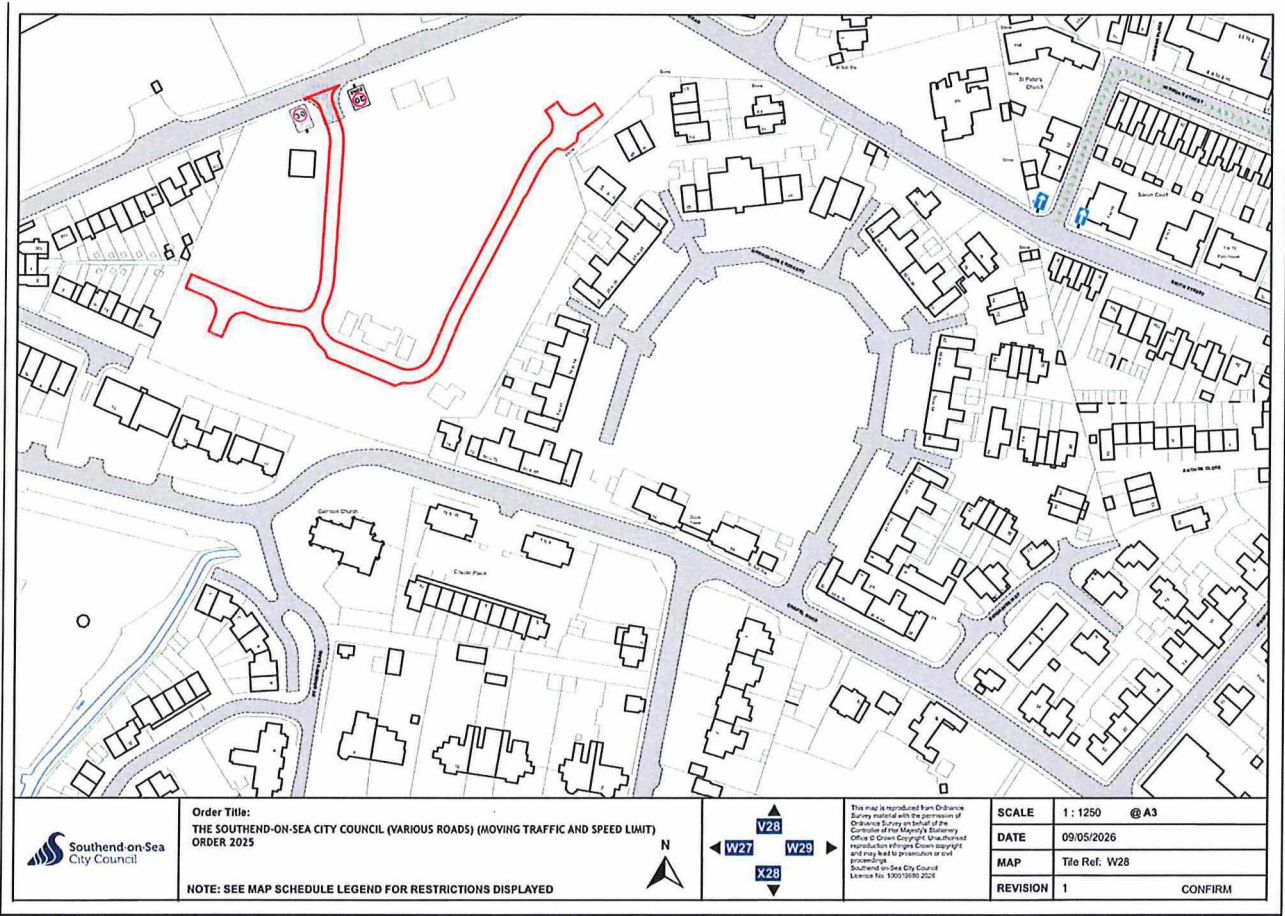
