Southend-on-Sea City Council in exercise of its powers under Sections 1, 2, 4 and 122 under the Road Traffic Regulation Act 1984 (as amended) ("the 1984 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III and Part IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. Without prejudice to the validity of anything done or to the liability incurred in respect of any act or omission before the coming into operation of this Order, The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) (To be known as 'The 2021 Order') shall have effect as though:
 - (i) The items represented on the plans in Schedule 1 to this Order shall replace those corresponding plans as listed in the appropriate Schedule to the 2021 Order (as amended).
2. The effect of this Order is to (this article is an explanatory note and does not form part of the Order):

The effect of the Traffic Regulation Orders (TRO) would be to:

- (i) To introduce provisions restricting the use of Disabled Persons Parking Places within off-street parking places to vehicles displaying a valid Disabled Person's Badge.
 - (ii) To introduce Registration Services Visitor Parking Places subject to the applicable parking charges, a maximum stay of 1 hour, and no return within 2 hours at Civic Centre North Car Park.
 - (iii) To introduce a Staff Permit (Priority 1A) for employees with limited mobility approved by the Council, permitting vehicles displaying a valid permit to use designated Priority 1A Staff Permit bays.
 - (iv) To designate one specified disabled persons bays within Civic Centre East Car Park as Priority 1A Staff Permit only bays.
3. The remainder of The Southend Borough Council (Waiting, Loading, Stopping and Parking Places) (Map Based) (Consolidation) Order 2021 (as amended) shall remain in full force and effect.

Statement of Reason

Proposal:

- (i) To introduce provisions restricting the use of Disabled Persons Parking Places within off-street parking places to vehicles displaying a valid Disabled Person's Badge.
- (ii) To introduce Registration Services Visitor Parking Places subject to the applicable parking charges, a maximum stay of 1 hour, and no return within 2 hours at Civic Centre North Car Park.
- (iii) To introduce a Staff Permit (Priority 1A) for employees with limited mobility approved by the Council, permitting vehicles displaying a valid permit to use designated Priority 1A Staff Permit bays.
- (iv) To designate specified parking bays within Civic Centre East Car Park as Priority 1A Staff Permit only bays.

Reason

The permanent amendment to the current parking restrictions in this area is to support accessibility, fairness and inclusion by helping ensure disabled parking bays, visitors' parking places and staff permit (Priority 1A) for Employees remain available to those who rely on them.

These proposals have been carefully considered, for a balance to accommodate residents, and visitors whilst maintaining traffic flow.

Road Traffic Regulation Act 1984

The sections which the City Council are using for the implementation of the proposed scheme as above are 1, 2, 4 and 122. The grounds that encompassed the reason for these proposals in Section 1 of the Road Traffic Regulation Act 1984 are:

- a. for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- b. for preventing damage to the road or to any building on or near the road, or
- c. for preserving or improving the amenities of the area through which the road runs.

In addition, thorough consideration was given to the factors set out in Section 122 of the Road Traffic Regulation Act 1984 in proposing this scheme.

Traffic Signs Regulations and General Directions 2016

All of the associated signing and lining will be in accordance with Traffic Signs Regulations and General Directions (TSRGD) 2016.
